A Survey Fee of \$209, which includes site measurements, photos, permit inquiry and pulls; will be assessed on all projects requiring eyes on site or substantial research. This fee will be waived if the project is accepted within 14 days.

When exterior installation or painting is involved, User assumes all responsibility for protection of automobiles and other items; especially for the removal of valuables on or near the premises to be painted.

Payment in full is REQUIRED on all projects under \$1,000; otherwise a 2/3 (66%) down will initiate the project. Payment is due in full on the day of project completion.

All prices are ESTIMATES, subject to change based on materials supply, weather conditions, and unforeseeable circumstances. All sales are final - NO REFUNDS. Minimum order of \$50.
